The following amendments / clarifications are made which constitute the addendum to “Supply, Installation, Testing & Commissioning of Digital and Scientific Exhibits, Robots and Modelson Turn-key basis for Bangabandhu Sheikh Mujibur Rahman Novotheatre, Rajshahi ”

Clause	Existing clause	Amendment / Clarification
ITT 14.1(b)	The minimum specific experience as a Contractor or Subcontractor in supply of Digital and/or Scientific Exhibits with ancillary works or Scientific/IT equipment in a single contract in public sector successfully completed within the last 5 years with a value of at least BDT 60 (sixty) Million or USD 0.71 (zero point seven one) Million. Years shall be counted backward from the date of publication of IFT in the newspaper.	Regarding the change of minimum specific experience in supplying a single contract of value at least BDT 55 (Fifty five) million instead of BDT 60(Sixty) Million, it is clarified that there shall be no change in the clause in this regard.
		Regarding the query whether any local Tenderer can participate in the bid, it is clarified that if the local Tenderer fulfils all the qualification criteria as set in the Tender Document, then the local Tenderer can also participate in the bid.
		Regarding the query that how shall the eligible local Tenderer quote the price in the Tender, it is clarified that the local Tenderer shall quote the price for foreign goods, equipment etc in foreign currency and for local works and service in local currency. For the price quoted in BDT, VAT and IT shall be deducted from source as per the rules and regulation of the Government of Bangladesh And for the price quoted in foreign currency, the required amount of custom and import duties will be borne by the procuring authority


